#### **Position Overview:**

As a **Boilers and Systems Manager**, the primary work responsibilities and duties are to manage, monitor, maintain and control all aspects of the facilities boilers, generators, heat exchanger, PRV and other valve systems, R.O. systems and pump/water systems, ensuring safe, timely, efficient and effective facility operations.

You will work in coordination with the Plant Manager, other Maintenance Specialists, Department Managers, Wastewater Specialist and in conjunction with the Quality Control and Food Safety Managers.

## The duties and responsibilities of Boilers and Systems Manager will be as follows:

- Ensure that all equipment is maintained in accordance with the Food Safety Preventative Maintenance Plan and all service manuals. Assist in the development of Preventative Maintenance Schedules for pieces of equipment with no documented PM plan.
- Follow all Standard Operating Procedures (SOPs) related to the startup, operation, and regular maintenance of all systems and equipment with your purview. In conjunction with other Maintenance team staff, ensure that adequate cross training between other areas of the Maintenance Department is undertaken to provide backup for absences or holidays.
- Continuously monitor facilities and equipment to identify any developing issues; communicate regularly with
  operators; and notify other Maintenance Managers immediately of any developing problems and advise of
  appropriate steps to resolve the issue.
- Coordinate and schedule any required outside contractors in a timely and efficient manner and maintain all
  required security and food safety procedures when working with contracted services. Ensure all onsite
  contractors are monitored and follow all company policies.
- Ensure inventory management of required spare parts and approved supplies for production equipment are organized, adequate and current through placing and tracking purchase orders with approved suppliers.
- Be familiar with and follow HACCP, GMP (Good Manufacturing Practices), Food Safety, Food Security, Organic Certification, Standard Operating Procedures and all other applicable regulatory and company programs and policies.
- Receptive to a flexible work style and willingly assist with other functions where needed. Hours may vary, from
  time to time, according to production requirements, maintenance work, and repairs. This position may
  periodically require you to start work prior to the day's production or continue after production finishes. You must
  be willing to work on weekends and holidays to perform maintenance tasks which cannot be completed during
  normal production hours.

- Maintain and keep boiler, generator and other related production systems and parts in good condition. Maintain relationships with appropriate suppliers.
- Provide Maintenance support for all other production systems when needed.
- Perform root cause analysis and effective follow up measures for equipment breakdowns.
- Co-ordinate boiler and piping systems inspection by TSSA and/or insurance inspector as required. Ensure
  adherence and tracking of TSSA and Insurance documentation and are in accordance to regulations. Test
  Pressure Relieving Valves (PRV) valves periodically and document. Replace PRV valves as required and
  document.
- Working with the Water/Wastewater Maintenance Department, manage and perform maintenance to the MBR equipment, filters, UV lights, pressure tanks and the Navien boiler pumps and air turbines.

#### Requirements:

- Knowledge of boilers and pressure vessels with high and low pressures.
- Water treatment knowledge
- Solid troubleshooting capability.
- Excellent knowledge of Health & Safety, Lock-out/Tag-out procedures.
- Industrial Millwright license is required combined with a minimum of (3) three years of experience
- Minimum Grade 12 education or equivalent.
- Preference for candidates possessing a second license, especially an Industrial Electrician's license.
- Excellent mechanical aptitude.
- Excellent math skills.
- Excellent command of the English language.
